MINUTES

May 7, 2015 Meeting 10:00am

- 1. Call to Order. Chairman Charles Ciccotti called the meeting to order at 10:00am.
- 2. **Approval of Past Minutes**. Sheriff Crawford moved to accept the minutes from the December 2, 2014 meeting. Edward Macon seconded the motion, which passed unanimously.
- 3. **Public Comment.** Dan Schmitt, Chairman of the Private Security Services Advisory Board, spoke about certain applicants to the Private Security Services Advisory Board.
- 4. Closed Meeting Session. Chairman Charles Ciccotti motioned that the Nominations and Appointments Subcommittee of the Criminal Justice Services Board go into a closed meeting pursuant to Virginia Code § 2.2-3711(A)1 for the discussion and consideration of prospective candidates for appointment to the Private Security Services Advisory Board and the Court Appointed Special Advocate/Children's Justice Act Advisory Committee. The motion was seconded by Sheriff Crawford and the subcommittee went into a closed meeting.
- 5. Closed Meeting Certification. Chairman Charles Ciccotti motioned that the Nominations and Appointments Subcommittee of the Criminal Justice Services Board certify by a recorded vote that, to the best of each member's knowledge, only public business matters lawfully exempted from the open meeting requirements of the Virginia Freedom of Information Act and identified in the motion authorizing the closed meeting were heard, discussed or considered in the closed meeting.
