- 1. Call to Order. Chairman Edward Macon called the meeting to order at 10:00am.
- 2. **Approval of Past Minutes**. Sheriff Crawford moved to accept the minutes from the May 7, 2015 meeting. Robert Soles seconded the motion, which passed unanimously.
- 3. **Public Comment.** Dan Schmitt of RMC Events spoke about certain applicants to the Private Security Services Advisory Board.
- 4. Closed Meeting Session. Chairman Macon motioned that the subcommittee go into a closed meeting pursuant to Virginia Code § 2.2-3711(A)1 for the discussion and consideration of prospective candidates for appointment to the Private Security Services Advisory Board and the Court Appointed Special Advocate/Children's Justice Act Advisory Committee. The motion was seconded by Sheriff Crawford and passed unanimously by a vote from each member.
- 5. Closed Meeting Certification. Chairman Macon motioned that the subcommittee certify by a recorded vote that, to the best of each member's knowledge, only public business matters lawfully exempted from the open meeting requirements of the Virginia Freedom of Information Act and identified in the motion authorizing the closed meeting were heard, discussed or considered in the closed meeting. The motion was seconded by Mr. Vorhis and approved by a unanimous vote from each member.
- Recommendations. Chairman Macon made a motion that the subcommittee recommend to the Criminal Justice Services Board that the following individuals be appointed to the Private Security Services Advisory Board and the Court Appointed Special

Advocate/Children's Justice Act Advisory Committee. Sheriff Crawford seconded the motion and the subcommittee voted unanimously to pass the motion.
