#### 3. Division Update.

Mr. Richard Collins, Standards and Policy Manager, DCJS Division of Law Enforcement, provided updates to the Committee regarding the Law Enforcement Division and training updates.

-Recognition: Sharon Gray, Field Services and Audits manager s officially retiring on July 1, 2024. Frank Pitzer, has been promoted to fill the vacancy left by Sharon's retirement.

- VLEPSC: On May 30, 2024, a commission meeting was held. Eight (8) agencies appeared before the commission seeking accreditation or re-accreditation and were successfully accredited or re-accredited. Total number of accredited agencies in the Commonwealth is 110. Chief Scott Booth, Roanoke PD was appointed Chair, and Sheriff Draper, Martinsville, was appointed as Vice-Chair. Thank you to Sheriff Balderson for his tenure as Chair of the Commission.

- -Decertifications: To date we have received 73 decertifications for 2024. Last year we received 130 submission with 116 decertifications being completed. There are currently 20 in the appeals process.
- -Staffing: Two (2) new positions will be added to the LE Division-a VLEPSC coordinator, and a Marcus Alert/CIT Specialist. They will be introduced at the next COT meeting.
- -Alternative Training Path for DOC to Jail Officer: As requested at the last COT meeting, a meeting with Director Miller, myself, Sharon Gray, Frank Pitzer, Kristi Shalton, Superintendent Smith, representatives from DOC and regional jail representatives was held this morning. It was a productive meeting with good dialogue.
- -Today, Kristi Shalton will be providing a legislative update and Brandon Williams will be providing a Model Lesson Plan update to the Board.
